



IMPORTANT: Lockbox Invoice Remittance

Dear Administrator:

We know it takes time to send payments to the Church Pension Group for your employees' health, life, and pension benefits, and we thank you for your diligence.

As a reminder, CPG has several lockboxes for receiving payments with different lockbox numbers for each benefit type. Please be sure to use the correct box number so we can process your payments correctly and efficiently:

- **When mailing payments via the United States Postal Service**, please continue to use the windowed envelope that we provide with your invoice. Make sure the return address on your invoice remittance stub shows through the window. If that envelope is not available, please send your payment using the address on the remittance stub of your invoice.
- **When using a courier service (such as FedEx or UPS)**, please refer to this list and send your remittance to the appropriate address:
